- □ The Korean Association for Information Systems (KrAIS)
 - ☐ A Chapter of the Association for Information Systems (AIS)
 - Serving Korean members of AIS
 - Approved by AIS Council last December

■ The Goal of the KrAIS

- □ To promote the exchange of idea, experiences, and knowledge sharing among Korean scholars and professionals
- □ Engaged in the development, management, and use of information and communications systems and technology
- ☐ To fulfill its goals, KrAIS will closely cooperate with KMIS

Membership

- □ All members of KrAIS should be members of both AIS and KMIS
- A person wishing to be a member of the Chapter should present application to the Executive Board of KrAIS
- The Executive Board shall have the authority to determine wheth to accept the application
- Chapter Dues
 - The Executive Board shall have the authority to determine the KrAIS due and other payments to be made by the members of the Chapter
- Member Rights
 - ☐ To vote, participate in all KrAIS and AIS activities

Meetings of Members

- **□** Annual General Meeting
 - □ Two times per year
 - One in Korea (at KMIS Spring Conference)
 - The other in USA (at ICIS, AMCIS, or PACIS)
 - Ad hoc meetings shall be called by the Executive Board, if necessary
- **□** 22 members have currently been joined the KrAIS
- Notice of the meeting shall be delivered to the membership at lea
 10 days prior to meeting
- **□** 25% of KrAIS members shall constitute a quorum
- **□** Each member is entitled to one vote on a particular business

Executive Board

- **■** Members of the Executive Board shall consist of
 - President
 - □ Past President
 - President-Elect
 - □ Vice President
 - □ Past Vice President
 - □ Vice President Elect
 - Secretary
 - □ Treasurer
 - □ Directors (e.g., Special or At-large Directors)
- Duties of the Executive Board
 - ☐ Shall serve as the governing authority of the Chapter
 - □ Including property, business, and affairs of the Chapter
